The IDEAS-TIH is incorporated as a Section 8 Company promoted by the Indian Statistical Institute, Kolkata dedicated to conduct cutting edge, translational developments in the aforementioned areas. The specific objectives of the IDEAS-TIH are development of products, strengthening of entrepreneurship ecosystem by nurturing innovation and startups, and skill development pertaining to Data Science. In particular, the IDEAS-TIH Incubator is dedicated to support young and aspiring entrepreneurs in translation of ideas into prototypes. The IDEAS-TIH is inspiring the best talents to be entrepreneurs by providing support in the form of fellowship, guidance or mentorship, and co-working spaces for developing their ideas into products.

Call for Proposal:

Calling innovators and Startups with a product or validated MVP (Minimum Viable Product) to join our incubation program at IDEAS TIH (Technology Innovation Hub) at the Indian Statistical Institute, Kolkata. This is the third cohort for early-stage startups in product development or at least a 'ready to pilot' Minimum Demonstrable Product (MDP).

- Funding under SSS is against a equity participation by the IDEAS TIH in the startup company.
- The startup should be incorporated in India with more than 50% of its equity held by Indian citizens
- The maximum funding support will be decided on a caseto-case basis depending upon the technical promise and the resources needed.

How to apply:

IDEAS TIH will publish the details of the application process in its website https://www.ideas-tih.org/ with an end date of application. The end date may be revised if the number of applicants is low.

Usually applicants will need to submit an online proposal form, which will be made available in the above mentioned webpage, with details about their organization, description of the product idea, use cases for the product, target market, business case etc. A brief "pitch deck" may also need to be submitted.

Selection Process:

All proposals will be evaluated and executed as per the policies and procedures of the IDEAS-TIH with the final decision on evaluation and selection of startups resting with the IDEAS-TIH. Applicants may be required to appear in person and give a brief presentation / pitch before a selection committee.

A General Term Sheet (GTS) will be signed with the Startup prior to onboarding. The Term Sheet is not a commitment to invest and is conditional upon fulfillment of all statutory and regulatory compliances, the completion of due diligence, legal review and documentation that is satisfactory to the TIH.

Before funding, Due Diligence of the Startup to be carried out by an independent professional appointed by the TIH for the purpose.

During the tenure of engagement of the Startup in the Incubation Programme of IDEAS-TIH prior to any funding, the Startup may be incubated with any other incubator towards fulfilling its obligations, legal or otherwise.
